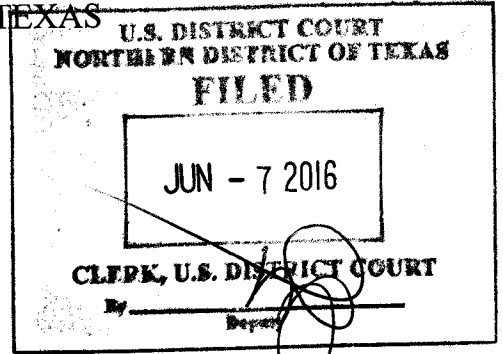

The Grand Jury charges:

Count One
Sex Trafficking of Children
(Violation of 18 U.S.C. § 1591(a) and (b)(2))

From on or about March 15, 2015 through on or about April 18, 2015, the exact dates being unknown, in the Dallas Division of the Northern District of Texas and elsewhere, the defendant, **Martavious Detrel Banks Keys a.k.a. "Cheese," a.k.a "Matt,"** knowingly recruited, enticed, harbored, transported, provided, obtained or maintained by any means, in and affecting interstate commerce, Jane Doe, who had not attained the age of 18 years, knowing or in reckless disregard of the fact that Jane Doe had not attained the age of 18 years and that Jane Doe would be caused to engage in a commercial sex act.

In violation of 18 U.S.C. § 1591(a) and (b)(2).

Forfeiture Notice
(18 U.S.C. § 1594(d) and 28 U.S.C. §2461(c))


Upon conviction for the offense alleged in Count One of this Indictment and pursuant to 18 U.S.C. § 1594(d), the defendant, **Martavious Detrel Banks Keys a.k.a. "Cheese," a.k.a "Matt,"** shall forfeit to the United States any property, real or personal, that was used or intended to be used to commit or to facilitate the commission of such violation and any property, real or personal, constituting or derived from, any proceeds that such person obtained, directly or indirectly, as a result of such violation.
