1	Ql.	What is your name?
2	Al.	My name is Ernest Scialabba.

4	Q2.	What is your position?
5	A2.	I am President and owner of Southern Vermont Cable Company ("SVCC").
6		
7	Q3.	What are your qualifications to sponsor the testimony that you will give in this
8		proceeding?

1	A3.	I have over forty years of experience in the cable television industry and have worked to
2		build a successful cable television system and to bring value to residents of Windham
3		County. I purchased cable systems in the towns of Newfane and Putney from Gateway
4		Cablevision and established SVCC in 1988. Within three years, I doubled the subscriber
5		base. During the past forty years, I have designed, upgraded, expanded, and rebuilt
6		SVCC's cable system and SVCC has expanded its services to include digital and HD
7		television channels, broadband internet service, and digital phone service. SVCC
8		currently serves approximately 2,450 subscribers and has approximately 123 miles of
9		cable plant in the towns of Dummerston, Jamaica, Newfane, Putney, and Townshend,
10		Vermont.

12	Q4.	What is the purpose of your testimony?
13	A4.	The intent of my testimony is to demonstrate that the acquisition by Comcast of SVCC's
14		assets and Comcast's ownership and operation of these assets will promote the general
15		good of Vermont.
16		
17	Q5.	Have you read Daniel M. Glanville's testimony in which he describes Comcast's plans
18		for the integration of the existing SVCC systems?
19	A5.	Yes.

21	Q6.	Why do you support the sale of assets to Comcast?

Although SVCC is a small organization, it has made significant capital investments in its
system throughout the years. However, technology continues to rapidly evolve, which in
turn necessitates the need for continued capital investment. Additionally, with the
increase in the number of video service options available to consumers, there is an
ongoing need to enhance and expand the products and services offered in order to remain
competitive. The sale of SVCC's assets to Comcast will increase the technical,
operational, and financial resources available to support the system. As described in Mr.
Glanville's testimony, in areas currently served by SVCC, Comcast plans to offer the
same services and products currently offered in Comcast's Brattleboro, Vermont system.
Comcast also has the technical and operational resources to support SVCC's subscribers.
Comcast is able to deliver 24/7 support and service to its subscribers and its subscribers
have many options for how they can contact Comcast. I am confident that an
organization like Comcast will provide SVCC's subscribers with quality customer service
and will continue to invest in SVCC's systems. Because of this, the transaction will
promote the general good of Vermont and benefit SVCC's current customers into the
future.
Will the abandonment of service by SVCC be consistent with the public interest?
Yes. Service to SVCC's customers will continue, which as described above will allow

the customers to receive great service and more offerings. As such service will be

provided by Comcast, it is in the public interest (and necessary) for SVCC to relinquish
