Brief details of claim

The Claimants' claims are for breach of the DPA 1998, DPA 2018, GDPR and/or UK GDPR (as applicable) and misuse of private information. The Claimants allege that, without their expectation, knowledge or consent, the Defendants deployed covert tracking technology within the Grindr App to collect and share various categories of personal data, including highly sensitive personal data, with third parties. The Claimants have each suffered damage and/or distress as a result of the Defendants' actions. The Claimants seek:

- 1. Compensation pursuant to section 13 of the DPA 1998; section 168 of the DPA 2018 and/or Article 82 of the GDPR/UK GDPR;
- 2. Damages for misuse of private information;
- 3. A compliance order pursuant to section 167 of the DPA 2018 and/or Articles 17/18/21 of the GDPR/UK GDPR;
- 4. An order pursuant to Articles 13/15 of the GDPR/UK GDPR;
- 5. Further or other relief: and 6. Costs

Value

The Claimants cannot say how much is likely to be recovered but anticipate it will, in any event, in aggregate be in excess of £100.000.
